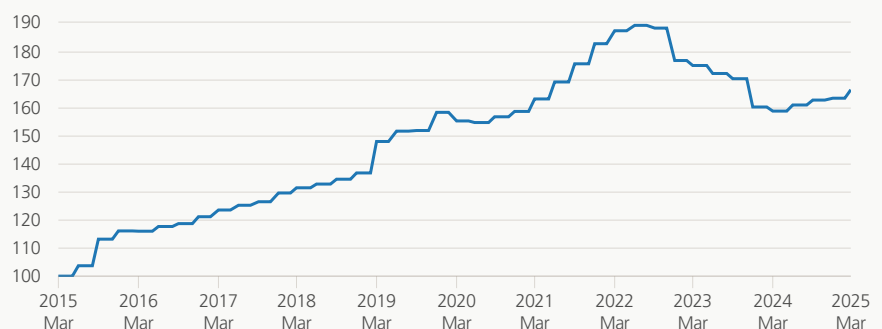


Real Estate Europe Direct

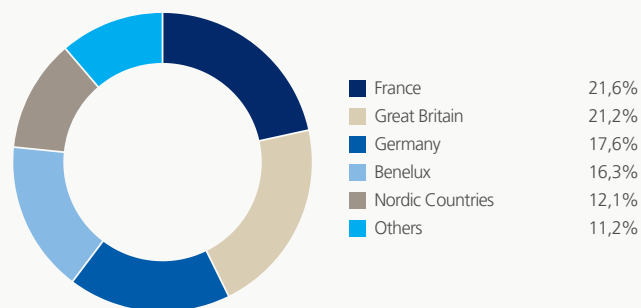
