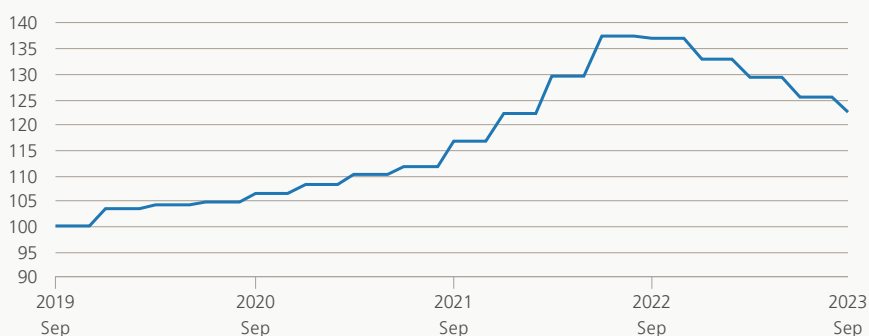


# Real Estate USA

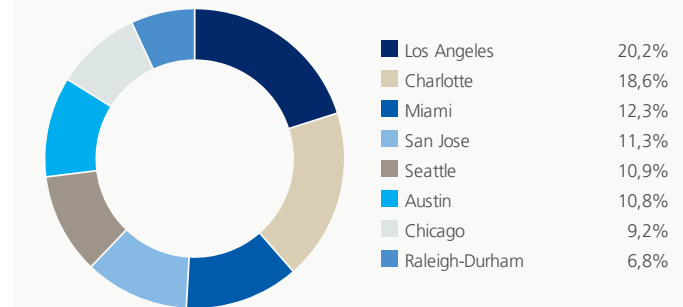
