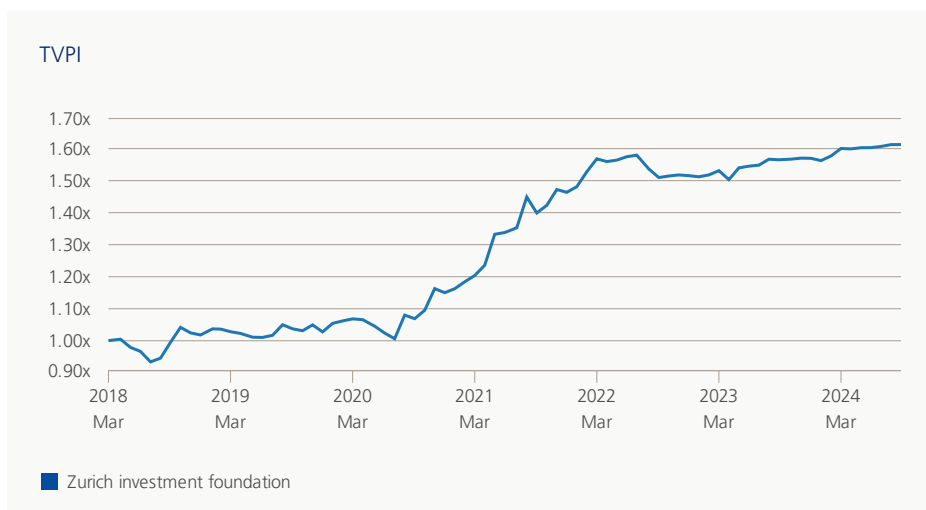


Private Equity III

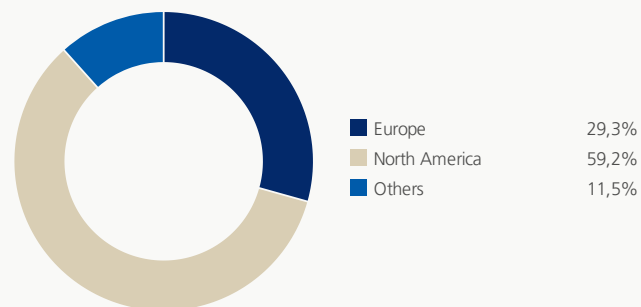
